



INFORMATION ON THE PROCESSING OF PERSONAL DATA EU Regulation 2016/679

Euroventilatori International Srl, in relation to your personal data, informs you of the following.

Given that:

- Euroventilatori International Srl is aligned with the high standards of confidentiality of personal data introduced by the European Data Protection Regulation (EU Reg. 2016/679), based on principles of correctness, lawfulness, transparency and protection of the rights of the data subject.
- Data collection may take place in various ways such as, by way of example, the application for registration in the Reserved Area, or by spontaneous conferment by the interested party, by accessing the website www.euroventilatori-int.com.

Data Controller and Data Processing Manager

The data controller is Euroventilatori International Srl, with registered office in San Pietro Mussolino (VI), Via Risorgimento 90, ITALY - VAT number 03038290247, in the person of the pro tempore legal representative, contact details: info@euroventilatori.com. The updated list of data processors and persons in charge of processing is kept at the headquarters of the person responsible for the processing.

Purpose of the processing and category of data

The data processed by Euroventilatori International Srl are collected and stored as a function of the management of the budgeting services present in the Reserved Area and customer support.

Processing methods, data communication obligations and storage time

The processing of personal data, owned by Euroventilatori International Srl and in charge of each of its employees or collaborators, as well as the employees and collaborators of the data processors, is carried out solely for the purposes indicated above, and can be carried out with mainly computerized procedures with the use of electronic or automated procedures and also in paper form. This treatment will include - in compliance with the principles of correctness, lawfulness, transparency and protection of confidentiality - the operations and data strictly necessary for the purpose. The data, although largely not required by law, are still useful and necessary for the performance of the required activities or services. If not provided, even partially, the requested data may result in the inability to use the requested services. The data will be kept for the period necessary to carry out the purposes referred to in the previous point.

Data recipients

The data collected may be disclosed for the purposes indicated above: subsidiaries / affiliates of Euroventilatori International Srl.

Rights of the interested party

The EU Privacy Regulation 2016/679 grants data subjects the exercise of specific rights, including those to ask the Data Controller: the access to their personal data, cancellation, transformation into anonymous form and blocking of data processed in violation of the law, request updating or rectification or integration, to oppose their use, obtain data portability, access to the Supervisory Authority to make a complaint. Those interested, may in any case exercise all the rights listed in articles 15 to 21 of EU Regulation 2016/679 also towards Euroventilatori International Srl without prejudice, however, to the limits deriving from the legitimate interest in the processing of their data for what has already been specified above. Privacy information (Article 13 EU Regulation 2016/679)

Below is some information and warnings on how to manage the site www.euroventilatori-int.com for the purposes of protecting the personal data of the interested parties.

Treatment of personal data

The ownership of the data, voluntarily given to the site in the availability of Euroventilatori International Srl, and also processed following consultation, use and dialogue with the site itself, is attributed to the same Company, based in San Pietro Mussolino (VI), Via Risorgimento 90, ITALY - VAT number 03038290247, in the person of the pro tempore legal representative, who processes the same data, as well as for the purpose of optimizing the use of the site, for the purposes of managing estimates and customer support services.

The treatments are carried out by the owner with paper, computerized, telematic methods on computer systems and servers in his / her availability, by the personnel in charge. The provision of the requested personal data is optional, but the refusal of consent to their processing may make it impossible to use the services provided through the specific site.

Euroventilatori International Srl collects data relating to access and navigation within the site exclusively to allow the operation of the services and sections that require user identification; uses the information collected for the technical administration of the site and for any statistical analysis about its use. Euroventilatori International Srl may use global statistical data on the type of traffic, and other information related to the site, without disseminating or communicating data relating to individual users to third parties.

Data recipients

Without prejudice to the purpose of managing budgeting and support services to customers, technical recipients of personal data, are the service providers appointed as data processors or appointees, within the scope of the stated purposes, to which Euroventilatori International Srl entrusts certain functional activities to services rendered (for example the organization of the contents on the site, the elaboration of studies and statistical research, detection of the degree of satisfaction with the quality of the services obtained). Personal data may be disclosed to public or private entities for the fulfillment of legal obligations.

Rights of interested parties and complaints

Interested parties may at any time check the data processed and exercise all rights (including those of rectification, updating and cancellation) provided for in articles 15 to 21 of EU Regulation 2016/679, by contacting info@euroventilatori.com. Furthermore, interested parties have the right to complain to the Data Protection Authority.

Site navigation

The use of session cookies is strictly functional to the optimization of the use of the site and therefore exclusively aimed at ensuring the best navigation within the site itself. Access by users is monitored, for statistical purposes only in aggregate mode, by Euroventilatori International Srl, by registering in specific log files which, however, do not persist for more than seven days and are deleted immediately after their aggregation. Other internet addresses to which this site may possibly "link" may contain tracking systems to which the owner of the site is unrelated. There is no guarantee that these external sites are equipped with suitable security systems aimed at protecting the data processed and preventing damage (eg from computer viruses).

Third party cookies for statistical or technical purposes

While browsing the site, the user can also receive cookies from different suppliers on his terminal (so-called "third party" cookies); this happens because on the visited website there may be elements that reside on servers other than the one on which the requested page is located. The Owner uses third-party cookies only for technical purposes, for example cookies issued to statistically analyze accesses / visits to the site (so-called "analytics" cookies) or to allow the use of parts of code issued by third parties, which guarantee a better use of the service (authentication, administration pages, etc.). Third party cookies for profiling / remarketing / social marketing purposes
